At our homeowners' meeting we were joined by Captain Will Hart Commander of District II and Deputy Eddie Vauthier – Community Relations Officer District II



Deputy Vauthier spoke to the homeowners on many safety issues. They wanted us to be aware that there have been recent reports (over 60) in other subdivisions near us (Cross Gates was mentioned) where cars were not locked or garage doors were left opened. He also said that many times people leave the interior door to the home unlocked and enter from the garage. Criminals survey an area where garage doors are left open and come back later if someone is home or during the day when people are at work.



Deputy Vauthier said that we were a very boring neighborhood. Only five calls were made last month. One medical issue, one 911 that turned out to be a false alarm and three other false alarms.



He said that the best protection is to always lock your doors to your cars, home and garage. If you are in the back yard working in your garden and the doors are unlocked, someone can enter your home and take whatever and leave without you even knowing it. Or worse, you could come back into your home and be surprised by the intruder.



Deputy Vauthier said "BE A NOSEY NEIGHBOR" if you see something suspicious or witness a crime in progress don't be a hero call 911. If you make a 911 call the most important thing is to remain on the line until you are told by the 911 operator that you may hang up.

Deputy Vauthier said that he would be happy to assist us if we were interested in joining the Neighborhood Watch program.



Another issue the Deputy discussed was the problem of children operating motor vehicles (golf carts, motor scooters, etc.) on public roads.



We were told that on private property they were fine, but not on our streets. If an officer sees a child driving, he said that they would take the child to their parents and talk to the parents about the law. They are not trying to terrorize children. Their goal is to make sure that everyone is safe and follows the law.

He said that other neighborhoods have similar problems and that they are often called to deal with this issue. He did not say what would be done if there are repeat occurrences.
